NVBC advocates for improved bicycling facilities, improved laws and law enforcement for bicyclists and for public education to improve conditions for Sharing the Road safely. We see our efforts as aligned with supporting improved conditions for all nonmotorized transportation. The NVBC has established strong working relationships with the Nevada Departments of Transportation and Public Safety, legislators, local transportation agencies, and local law enforcement. **Projects**

- Currently working to assure that federal transportation legislation – MAP-21 - is implemented in Nevada in such a way that bicycling and pedestrian improvements are fairly and adequately funded then constructed in a timely way.
- Worked with others to draft and pass a Vulnerable Users Law for Nevada in 2011 legislative session.
- Instrumental in creating a Share the Road, Share the Responsibility media campaign to stress the roles that motorists and bicyclists play in sharing the road safely.
